- 3 Heat-Retaining Test (In-House Test Method)
 - 1. Specimen Is Cut And Mounted In The Frame.
 - 2. Put The Specimen And Conduct The Test In The Condition Of 21-1°C, 65-5%RH.
 - Give The 500 Watt Light Source In The Distance Of 50–1cm High Above The Center Of The Specimen For 20 Minutes.
 - 4. Record The Surface Temperature Of Specimen In Every 2 Minutes Intervals During The Test.
